<i>Hazard – something that may cause harm or damage. Risk – the chance of it happening.</i>	<i>Young people, Leaders, Visitors?</i>	<i>Controls – Ways of making the activity safer by removing or reducing the risk from it. For example - you might use a different piece of equipment or you might change the way the activity is carried out.</i>	<i>Keep checking throughout the activity in case you need to change it...or even stop it! This is a great place to add comments which will be used as part of the review.</i>
Maintaining social distance at drop off and pick up: higher risk of infection spread if social distancing not maintained.	YP, Leaders, Parents	Clear expectations with all involved; drop off/pick up at Rec CP; parents to remain in vehicle, Scouts/Cubs/Beavers to assemble in predetermined small groups. If possible, ensure groups are allocated according to school/friendship groups. Facemasks to be worn by all Scouts & adults at times of drop off/pick up	
Crossing Oystermouth Road to gain access to/from Swansea beach	YP, Leaders	Cross Oystermouth Road at recognised crossing point, in manageable group size with at least two Leaders allocated to each group	
Maintaining social distance during activity: higher risk of infection spread if social distancing not maintained.	YP, Leaders	Limit group sizes as above. Ensure groups understand importance of social distancing as practicably as possible. Stress importance of maintaining social distancing with general public due likelihood of interaction during event	
Hygiene of people: higher risk of infection spread if proper hand washing not carried out.	YP, Leaders	Clear expectations with all involved, provide hand sanitiser for members on arrival, departure and during as required.	
Hygiene of activity equipment: Higher risk of infection spread if hygiene not carried out.	YP, Leaders	Cleaning of activity equipment before and after group use, assigning specific items to individuals for the evening, limiting volume of equipment used, including consumables such as paper.	
Use of outdoor spaces: un-even ground, access to space less controlled, cannot be cleaned.	YP	Choice of location appropriate to activity, briefing to leaders and young people on boundaries, checks on the location ahead of use by leaders, hand sanitiser available for all participants.	
Slips, trips and falls: risk of injury due to uneven/open ground	YP	Briefing to leaders and young people on possible hazards: Stress importance of keeping to boundaries. Importance of wearing suitable footwear as hazards can be out of sight beneath sand	
Hygiene associated with drinking from communal beakers: higher risk of cross contamination and infection spread	YP	Inform parents prior to event that all participants to bring along their own drinks/drink bottles – no drinks provided by leaders

Lack of appropriate clothing for anticipated weather conditions	YP	Inform parents prior to event all young people to dress appropriately for weather conditions: Check on arrival that young people are carrying/wearing appropriate clothing for the event/ weather conditions on the night. Ensure supply of sunscreen available if weather conditions dictate	
Beach Fire pits	YP, Leaders	Ensure YP have clear understanding of dangers associated with building, lighting and maintaining a fire pit, i.e not building fires too high, cooking on embers, restricting numbers cooking at any one time. Ensure Leaders are allocated to specific groups to keep a watchful eye and advise where necessary. Water container on standby to extinguish fire if and when required.	
Fire Pit cooking (marshmallow toasting only); risk of burns	YP, Leaders	Stress importance of dangers associated with marshmallow toasting on open fire to all YP; ensure each has their own toasting fork. First Aid Kit available	
Beach BBQ	YP, Leaders	Ensure BBQ sited clear of games area and one Leader located to be in charge for duration of event. Wear disposable gloves when handling all food. Ensure specific individuals allocated to handing out ketchup to avoid cross contamination.	
BBQ Food allergies/intolerances	YP, Leaders	Identify any food allergies/intolerances in advance of BBQ and plan accordingly	
Use of public places	YP, Leaders	Beach is open to the general public, social distancing advised, no particular rules/restrictions other than social distancing. Discussion with YP on the night will cover this aspect. YP to be reminded that social distancing is required and to avoid any situation which brings them in close proximity to members of the general public.	
YP shielding or self isolating	YP, Leaders	No YP or Leaders presently in this category	
Track and Trace	YP, Leaders	A system has been agreed with the Group that a record of attendees will be made and kept on file in the Group headquarters. This topic is also listed in the use of headquarters RA.	
Changes to Covid situation or activity plan	YP, Leaders, Parents	Any changes to Covid situation or activity arrangements will be communicated to all concerned via e-mail, text or social media
